Coles County Soil & Water Conservation District Foundation 2019 Chili Supper Gun Raffle Rules and Regulations

1. **Eligibility:** Raffle is open to all legal residents of the fifty (50) United States and District of Columbia who are at least 18 years of age at time of entry. Regardless of where the entrant is from, a prize must be accepted in the state of Illinois. The winning tickets will be drawn by a person who did not purchase a raffle ticket. This will allow Coles County Soil & Water Conservation District Foundation Board members and sponsor affiliated persons to be eligible to win a prize.
2. **Sponsor:** This raffle is being sponsored by the Coles County Soil & Water Conservation District Foundation, registered as a non-profit organization in Illinois.
3. **Agreement to Official Rules:** Participation in the raffle constitutes entrants full and unconditional agreement to and acceptance of these rules and the decisions of the sponsor(s), which are final and binding. Winning a prize is contingent upon being compliant with these official rules and fulfilling all requirements set forth herein.
4. **Raffle period:** This raffle will begin on January 11, 2019 and end on February 16, 2019.
5. **Prize Drawing:** The drawing will take place at American Legion Post 88, located at 1903 Maple Avenue, Mattoon, Illinois. The drawing will be held on February 16, 2019. A minimum of at least three Coles County Soil & Water Conservation District Foundation board members will be present at the drawing. Winner will be announced at time of drawing. In the event that the winner is not present, winner will be notified by phone and/or email. You need not be present to win.
6. **Prize:** Winner will choose one of the following: \$1000, or Hunter Package (Remington 1100 Sporting 12-Gauge and Savage Arms 220 Slug 20-Gauge), or Defender Package (Smith & Wesson 9mm, Beretta Pico .380, and Mossberg 500 12-Gauge). Raffle winners will have 60 days to claim their prize. If a winner fails to accept their prize within 60 days, that prize will be forfeited, and the Coles County Soil & Water Conservation District Foundation will retain the prize for use as it sees fit. These prizes are non-transferable. In order to receive a firearm prize, the winner must be allowed to legally own and possess a firearm and are bound to all state and federal laws pertaining to taking possession of a firearm. In order to receive a firearm prize, the winners may have to pass a background check in the state of their residence. If the winner is unable to pass the background check they will be given \$1000, the value of the prize.
7. **Taxes:** The winners will be responsible for any taxes in the State of Illinois of their state of residence.
8. **Tickets and Entering Contest:** Ticket price is \$20 each, \$50 for 3 tickets, or \$100 for 7 tickets, and tickets can be purchased from any foundation board member, at the Coles County Soil & Water Conservation District, and at Wide Eurp's Guns. Additional locations will be posted on colescountyswcd.org when they become available. There will be up to 300 tickets sold. The tickets will be numbered but entrants must write legibly their name, phone number, address, and email address if available. In the event that entrants contact information is not legible, the ticket number will be announced, and the winner must have their matching ticket stub to claim the prize.
9. **Method of payment:** Coles County Soil & Water Conservation District Foundation will accept cash or check to purchase tickets. NFS checks will have a \$25 fee assessed and checks must clear prior to drawing to be valid. Checks should be made out to Coles County SWCD Foundation.
10. **General Conditions:** Coles County Soil & Water Conservation District Foundation in their discretion reserves the right to disqualify any individual it finds tampering with the entry process or operation of the raffle or to be acting in violation with these official rules. Any attempt by any person or organization to damage, interfere with or undermine the legitimate operation of this raffle may be a violation of criminal and civil law. Should such an attempt be made, Coles County Soil & Water Conservation District Foundation reserves the right to seek damages (including attorneys fees) and any other remedies from any such person to the fullest extent permitted by law. Failure of Coles County Soil & Water Conservation District Foundation to enforce any provision of these official rules shall not constitute a waiver of that provision.
11. **Release and limitation of liability:** By participating in the raffle participants agree to release and hold harmless Coles County Soil & Water Conservation District Foundation and any of its associates, agents, board members, league members, vendors, other companies and/or their affiliates as well as any person or company acting on behalf or volunteering for Coles County Soil & Water Conservation District Foundation for the purpose of this raffle from or against any and all claims or cause of action arising out of participation in this raffle, or receipt or use of the prizes. Entrant also waives the right to claim any damages, whatsoever, including but not limited to, punitive, consequential, direct or indirect damages.
